INTRODUCTION

Glorious Vision University, Ogwa, Edo State is a private faith-based University, founded by The Apostolic Church Nigeria (TACN), LAWNA Territory. The institution is licensed by the Federal Government of Nigeria through the National Universities Commission (NUC) on 7th March, 2011. The University commenced its academic activities in 2011 and has completed thirteen academic sessions in 2023/2024 academic session.

The Governing Council of the University wishes to recruit an astute conscientious, highly experienced, visionary, dynamic and God-fearing Vice-Chancellor who will build a formidable team and move the University towards realizing the goals and dreams of the founders.

LOCATION

Glorious Vision University is located in Ogwa, Esan West Local Government Area of Edo State, Nigeria. The campus is on the Ogwa-Ehor Road, off Benin-Auchi/Ekpoma Road. It is 30minutes drive from Agbor, Uromi and Ekpoma; and one and half hour drive from Benin-City. The University also has its Lagos Campus approved by NUC, situated at Orisigun Ketu.

THE UNIVERSITY

Glorious Vision University operates a Collegiate system, presently with four Colleges namely: College of Basic & Applied Sciences (COLBAS), College of Humanities (COLHUM); College of Law (COLLAW) and College of Management and Social Sciences (COLMASS). Each College has different departments and in all a total of thirteen departments and nineteen undergraduate academic programmes. The University also has a School of Postgraduate Studies.

THE POSITION

The Vice-Chancellor is the Chief Executive and Academic Head of the University, overseeing its day-to-day operations. He/She is Chairman of the Senate, Congregation and a member of the Governing Council. The Vice-Chancellor shall carryout the underlisted functions among others:

- i. Be responsible to the Governing Council for the maintenance of peace, law and order in the University;

- ii. Be competent at all times to advise the Governing Council on matters affecting the policy, finance and administration of the University;
- iii. Regulate the admission of students, subject to the guidance and procedure approved by the senate and other statutory bodies;
- iv. Be responsible for staff and students' discipline and welfare in the University.

THE CANDIDATE

The candidate for the post of the Vice-Chancellor is required to possess a good University education and should be a proven successful manager of human and material resources. Specifically, the following are expected of the candidate:

- a. Must be a distinguished scholar with exceptional academic and administrative records;
- b. Must be a tested and trusted manager of both human and material resources;
- c. Must have spent not less than twelve (12) years in the University system with at least ten (10) years of experience as a professor (Or about 8 years as a Professor, with sufficient experience in relevant leadership position);
- d. Must have an in-depth knowledge and understanding of the vision and mission of the University;
- e. Must have high moral standards, impeccable character and proven integrity with commitment to best practices in corporate governance with particular utilization of emphasis on accountability, transparency and probity, and must ensure judicious utilization of scarce resources for optimum public good.
- f. Must be able to attract research grants and complimentary fund from local and international agencies and thereby uplifting the academic status of the University;
- g. Must be accountable and possess the required integrity in the management of funds and should be able to allocate financial resources appropriately;
- h. Must demonstrate inter-personal and team building skills and also have the capacity to manage staff, students and members of the University community;
- i. Must be a leader who by his pedigree command the respect and loyalty of staff and students;
- j. Should have the capacity to attract, motivate and retain highly qualified and talented staff;
- k. Should possess entrepreneurship initiatives, attract extra-statutory funds and other resources for the University's development;
- l. Have excellent oral and written skills;
- m. Should articulate and ensure the enforcement of the University's laws and regulations;
- n. Must be physically and mentally sound;
- o. Must be highly proficient in the use of computer and be committed to development of ICT into the programme and services of the University;
- p. Must not be above sixty-five (65) years of age by October, 2024.
